Corporate Status

Tax Deductions Now Possible

It is my pleasure to announce to all members and supporters of W.A. R. Inc. that we have achieved official 501(c)(3) non-profit status with the IRS. Why is this important? With 501(c)(3) status all contributions to our Corporation are now deductible from federal income tax. Because we achieved this status prior to the year-end 2009, all donations to W.A.R., Inc. received during 2009 will be tax deductible for 2009. The IRS requires receipts from the non-profits for deductions of \$250 and up. You will need to see Jenny to obtain the proper documentation. Now we will also qualify for numerous grant programs that require 501(c)(3) status to participate.

With the 501(c)(3) designation goes new responsibilities and limitations. I will not go into all the issues but there are a couple of very important items. First, record keeping needs to be accurate and up to date as it relates to voting and financial matters. I don't believe this will be an issue as the appropriate officers have anticipated the need. The process of qualification required us to provide a statement of our goals as they relate to nonprofit status. We have declared that our main objective is to "educate" the public on issues of environmental and social relevance in our Nature Coast area. We will need to monitor our activities to assure that the ma-

For instance, dealing with members of the Citrus County Board of County Commissioners or members of the Florida Legislature while attempting to influence specific legislation falls under this limitation. Spending more than 5% of our efforts as a corporation in the above areas could void our status. Under no circumstances should any member speak to legislators as a representative of W.A.R., Inc. unless directed to by the Board of Directors. We are free to spend as much time as we want dealing with agencies of government and the public concerning the issues we are addressing. Finally, we, as a corporation cannot endorse or contribute to the campaign of any candidate for public office. If you are unsure how to proceed check with the Board.
